- a) Two (2) Passport Photos (*Write Your ID Card Number At The Back*)
- b) Security Steward Certificate (*Original And 1 Copy*)
- c) Affidavit from Civil Court regarding any pending criminal court cases.
- d) Witness To Signature On Application (*Required For Section 8: Applicant's Declaration*)
- e) Conduct Certificate (*The original document, issued by the Criminal Records Office at 18 Market Street, Floriana, and must be dated no more than three months prior to the application's submission*).
- f) A valid First Aid Certification issued by an accredited awarding body.
- g) **If the applicant is a Maltese Government Employee:**
 - A declaration from the Human Resources section of the respective Department is required, confirming the applicant's salary scale and stating whether there are any objections to the issuance of a Security Stewards in Sports Venues license.
- h) **If the applicant is a citizen of an EU Member State other than Malta, or a Third Country national:**
 - An official convictions record from the applicant's country of nationality, together with details of any pending criminal proceedings. All documents must be originals and issued within the last three (3) months:
 - In case of decided cases indicate the charge and what the punishment was given.
 - In the case of pending cases indicate what the charge is.
 - Original and a copy of passport. Original and a copy of ID card.
